

In continuation of this Department’s sanction letter of even no. dated 15th February, 2013, I am directed to convey the sanction of the President to the payment of final instalment of recurring grant of Rs.1,24,09,537/- (Rupees One Crore Twenty Four Lakh Nine Thousand Five Hundred and Thirty Seven only) under General Expenditure Head to the Secretary, Education Department, Government of Odisha under NGO Component towards the expenditure incurred on implementation of the Centrally Sponsored Scheme of Inclusive Education for the Disabled at Secondary Stage(IEDSS) in the State of Odisha during 2011-12 being paid during 2013-14 on full reimbursement basis as per details given in the annexure subject to the condition that necessary top up money has been released by the State Government and the teachers are qualified as per the scheme guidelines.
