
Sir,

In continuation of this Department's sanction letter No.F. 14-59/2010-IEDC dated 28th March, 2011 and consequent letter of even no. dated 13th April, 2012, I am directed to convey the sanction of the President to the payment of 2nd instalment of Rs. 94,60,000/- (Rupees Ninety Four Lakh and Sixty Thousand only) under Capital Expenditure Head to the Secretary, Education Department, Government of Uttarakhand under State Component towards the expenditure incurred on implementation of the Centrally Sponsored Scheme of Inclusive Education for the Disabled at Secondary Stage(IEDSS) in the State of Uttarakhand sanctioned during 2011-12 being paid during 2013-14 on reimbursement basis as per details given in the annexure subject to the condition that necessary top up money has been released by the State Government and the teachers are qualified as per the scheme guidelines. Total release for 2010-11 and 2011-12 including this sanction comes to Rs. 2,34,51,725/-.

2. The guidelines issued by the Government of India from time to time regarding monitoring, management, financial control and other procedure would be followed in the execution of the scheme.


3. Any other relevant condition specified in general financial rules 2005 as amended from time to time could be followed.


